



INDIVIDUAL MEMBERSHIP:

(\$50 per annum excl.GST)

In addition to the general benefits of BANZ membership, Individual membership will entitle the individual to a 15% reduction on all BANZ event registration fees and listing on the BANZ membership list (not the Who's Who web page).

ASSOCIATE MEMBERSHIP:

- one logo placement on the BANZ web site (excluding the home page) with hyperlink to own web page, and
